An Audit includes examining on a test basis, evidence supporting the accounts and disclosures in the financial statements. An Audit also includes assessing the accounting principles used and significant estimates made by the management, as well as evaluating the overall financial statement presentation. We believe that our Audit provides a reasonable basis of our opinion.

2. We further report that:

- (a) We have obtained all the information and explanation which to the best of our knowledge and belief were necessary for the purpose of our Audit.
- (b) The Balance Sheet and Income Expenditure Account dealt with the report are in agreement with the Books of Accounts.
- (c) In our opinion and to the best of information and according to the explanations given to us, the statements gave a true and fair view subject to the comments given below:

- (i) The FD with SBI matured on 27.10.21 having maturity value of Rs.11,01,600/- was renewed only for Rs.10,90,157/- . This matter has been brought to the notice of SBI in writing and awaiting for their action.
- (ii) Interest accrued on FD with Banks is not properly entered in the books of accounts, but the 26 AS details is higher than the books of accounts . This difference is treated as accrued interest in the books of accounts. This matter also brought to the notice of the concerned Banks in writing. Till the Audit is completed, no reply was received from Banks.
- (iii) Ammortisation of Renovation expenses during the year was changed from 1/3rd to 2/3rd.
- (iv) Samiti is advised to segregate its FD amount details with the funds Employed by it.
