#### **INTERNAL AUDITORS' REPORT**

To, BSS Patrons and Members

We observed the following, during the course of internal audit of BSS FOR THE FY 2022-23.

- (A) Security charges of Rs.3,13,500/- and Maintenance charges of Rs.4,01,653/- pertaining to the Year 21-22 have been clubbed as Rs.7,15,163/- in the current Year's Income and Expenditure Statement (under Previous Year).
- (B) Interest on FDs:
- (i) Central Bank of India Interest as per their Interest Certificate is "Interest Paid Rs.49,393/- and Interest Accrued Rs.57,523/-". However, in the Income & Expenditure Account only Rs.57,480/- is considered, thus Rs.49,436/- has been considered less.
- (ii) Interest earned this year is less by Rs.72,583/- compared to last year in spite of increase in FD amount by 16.65 lakhs. This may be because most of the FD are invested at a lower rate of interest.
- (iii) The number of FDs kept at various banks may be reduced and it is recommended that the FDs may be parked in banks which may give 7% interest. Some FDs which are yielding 5% may be closed, with pre closure charge and invested in bank which gives 7% interest.
- (C) ITR as per IT Returns pertaining FY 21-22 (AY 22-23) Rs.44,151/- was refunded by the Department. However, Rs.26, 373/- received on 11/05/2023 (refund credited to SVC Co-op Bank) Rs.20,427/- has been adjusted against earlier demand put forth by IT Deportment. This needs to be followed up as it is not clarified.
- (D) Water Charges have been paid for FY Rs.2021-22 Rs.40, 787/- and for FY 2022-23 Rs.10,485/-. It seems water charges bill was not raised by BMC, but provision could have ben made.
- (E) Depreciation: It is felt that depreciation at 10% be claimed on office building (Flat) which can reduce surplus without cash outflow (around Rs.1.12 lakhs).
